Please note that registration deadlines in the District are 21 days prior to the election, unless the voter opts to register in-person on Election Day.

Board is Tuesday, July 7, 2020; November General Election is Tuesday, November 3, 2020 [Deadline to request an absentee ballot to be mailed to you is Tuesday, October 27, 2020. Your request must be received by your Registrar by 5:00 p.m.]. Please note that registration deadlines in Virginia are 22 days prior to the election. Also, there may be county/municipal elections whose dates are not reflected above.
